- 4. Consultants may associate with other consultants to enhance their qualifications.
- 5. Expressions of interest shall be delivered online through e-GP system <u>www.bolpatra.gov.np/egp</u> [or manually to the address Trade and Export Promotion Centre, Pulchowk, Lalitpur on or before one months from the date of publication.
- 6. In case the last date of obtaining and submission of the EOI documents happens to be a holiday, the next working day will be deemed as the due date but the time will be the same as stipulated.
- 7. The evaluation of EOI will be based on the format provided by the centre.
- 8. EOI will be assessed based on *Qualification [35%], Experience [50%] and Capacity [15%] of* consulting firm and key personnel. Based on evaluation of EOI, only shortlisted firms will be invited to submit technical and financial proposal through a request for proposal.
- 9. Minimum score to pass the EOI is 60.
- 10. Trade & Export Promotion Centre reserves the right to accept or reject the proposal partially or fully.
